Minutes of the Annual Conference of the New Zealand Post Primary Teachers' Association Incorporated held at the Brentwood Hotel, Kilbirnie, Wellington, commencing at 11.00 a.m. on Tuesday 26 September, continuing at 8.40 a.m. on Wednesday 27 September and 8.40 a.m. on Thursday 28 September 2023.
